WHEREAS, the Board of Las Gallinas Valley Sanitary District adopted Resolution No. 2015-2030 on March 26, 2015 which set a public hearing on the sewer service charges for 2015-16 for Thursday, May 28, 2015 at 6:00 p.m. a copy of which is attached as Exhibit A and by reference incorporated herein;
