

### **SANITARY SEWER EASEMENT**

All that real property situate in an Unincorporated Area, County of Marin, State of California, being a portion of the Lands of County of Marin, as described in Book U of Deeds, at Page 582, also being a portion of Parcel 1 as shown on "Parcel Map of Rotary Valley Senior Housing" filed in Book 26 of Parcel Maps at Page 21, Official Records of Marin County and being more particularly described as follows:

Being an easement 15 feet in width, laying 7.5 feet each side of the following described Center Line.

Commencing at a ¾" Iron Pipe and Tag "RCE 12094" at the most westerly corner of Parcel 2 of said Parcel Map filed in Book 26 of Parcel Maps at Page 21 and being a point in the easterly Right-of-Way of Mount Lassen Drive as shown in said Parcel Map, thence southerly along said easterly Right-of-Way and westerly line along a non-tangent curve to the left having a radius of 178.00 feet and which center bears North 76°57′43" East; thence along said curve through an included angle of 5°55′18" and arc length of 18.40 feet to the most westerly corner of said Parcel 1; thence southerly along the westerly line of said Parcel 1 and continuing along said non-tangent curve to the left having a radius of 178.00 feet and which center bears North 71°02′25" East; thence along said curve through an included angle of 8°44′07" and arc length of 27.14 feet; thence South 23°19′47" East, 19.99 feet to a non-tangent curve to the right having a radius of 381.00 feet and which center bears South 65°18′19" West; thence along said curve through an included angle of 19°16′02" and arc length of 128.12 feet; to the True Point of Beginning.



# RESOLUTION NO. 2012-128 RESOLUTION OF THE MARIN COUNTY BOARD OF SUPERVISORS AUTHORIZING CONVEYANCE OF A SANITARY SEWER EASEMENT TO LAS GALLINAS VALLEY SANITARY DISTRICT

WHEREAS, the COUNTY OF MARIN, a political subdivision of the State of California, hereinafter referred to as "County", is the owner of that certain real property identified as APN 164-640-01 located in the County of Marin, State of California, and commonly known as 2 Jeannette Prandi Center: and

WHEREAS, LAS GALLINAS VALLEY SANITARY DISTRICT, a public corporation. hereinafter referred to as "LGVSD", operates an underground sanitary sewer line across County's property; and

WHEREAS, LGVSD determined it was necessary for public safety and environmental health purposes to relocate the sanitary sewer line on a portion of County's property as part of the Miller Creek Sanitary Sewer Relocation Project, hereinafter referred to as "project"; and

WHEREAS, LGVSD obtained a Permit to Enter and Construct from the County allowing for realignment and construction of the new sanitary sewer pipeline; and

WHEREAS, County staff determined that it is necessary to grant to LGVSD an easement for sanitary sewer purposes to accommodate the new facilities; and

WHEREAS, LGVSD has agreed to terminate their real property interest associated with the existing sanitary sewer pipeline by Quitclaim Deed concurrent with the conveyance of the herein described easement; and

WHEREAS, the conveyance of a new easement for sanitary sewer purposes to LAS GALLINAS VALLEY SANITARY SEWER DISTRICT, a public corporation, is recommended as a benefit to the public and in order to serve properties in and around the project.

NOW, THEREFORE, BE IT RESOLVED that the President of the Board of Supervisors is hereby authorized to grant and convey said EASEMENT DEED on behalf of the COUNTY OF MARIN.

FURTHER, BE IT RESOLVED that this Resolution shall be attached to the Easement Deed conveying said easement and shall be recorded together with said deed in the Marin County Recorder's Office.
