WHEREAS, said improvement bonds were refunded under the provisions of the Refunding Act of 1984 for 1915 Improvement Act Bonds and the Los Ranchitos Assessment District was reassessed and combined with the North Circle Assessment District to create the Consolidated Reassessment and Refunding District of 2003 (the "Reassessment District"), and;

WHEREAS, subsequent to the payment of all bonds and the interest thereon relating to the Reassessment District, there remains a balance in each of the following Reassessment District accounts, as of September 30, 2015:

THEREFORE BE IT RESOLVED, in accordance with Section 8885 of the Streets and Highways Code of California, the Board hereby declares the balance of the Los Ranchitos Reserve Account as surplus, declares the cash balance held for the Reassessment District as surplus, orders the disposition of the surplus in accordance with all applicable law, and approves the Closeout Analysis and Findings Report prepared by NBS.

### **EXECUTIVE SUMMARY**

The Las Gallinas Valley Sanitary District (the "LGVSD") retained NBS for the purpose of preparing a Closeout Analysis and Findings Report for the Consolidated Reassessment and Refunding District of 2003 (the "Reassessment District"). The purpose of this analysis is to determine the appropriate disposition of surplus funds in accordance with all applicable laws. The LGVSD's legal counsel should review any recommended action stated herein prior to implementation.

The Reassessment District was made up of two assessment districts previously established by the LGVSD to finance a variety of public improvements, each labeled as a "Zone" within the Reassessment District: the North Circle Zone and the Los Ranchitos Zone.

A Reserve Account for each Zone was established in the Reserve Fund for the \$1,736,409.48 Limited Obligation Refunding Improvement Bonds, Consolidated Reassessment and Refunding District of 2003, Series 2003 (the "Bonds"). The remaining North Circle Zone portion of the Bonds was retired ahead of schedule in September 2012, and that Zone's Reserve Account was fully-liquidated for such purpose. The remaining Los Ranchitos Zone portion of the Bonds was also retired ahead of schedule in September 2015, and the majority of that Zone's Reserve Account, along with the full amount in the Redemption Fund was used for such purpose.

As of September 30, 2015, there remained an excess of \$14,422.85 in the Los Ranchitos Zone Reserve Account, in addition to the \$7,660.77 in cash the LGVSD is holding for the Reassessment District, which is not related to the Reserve Fund or Redemption Fund. NBS recommends all excess Reserve Account funds be refunded to the owners of the 68 properties within the Los Ranchitos Zone of the Reassessment District, that \$7,500 of the Reassessment District cash be used to pay the administrative expenses related to the preparation of this report, and the remaining cash balance of \$160.77 be transferred to the general fund or the LGVSD. See Sections 1.3 and 1.4 of this report for further details.

One property within the Los Ranchitos Zone is delinquent in the payment of special assessments for the second installment for Fiscal Year 2014/15. This should not affect any refunds due to the property owner, as the Reassessment District is on the Marin County Teeter Plan, which ensures 100% of the special assessments levied are apportioned to LGVSD by the County of Marin, regardless of property tax delinquencies.

The LGVSD and the Bonds are not subject to any arbitrage rebate requirement because the LGVSD qualifies for the "small issuer exemption", as the aggregate amount of all tax-exempt bonds issued by the LGVSD during calendar year 2003 did not exceed \$5,000,000; therefore, no arbitrage rebate analysis is included as part of the surplus funds analysis.

Lastly, NBS recommends the LGVSD adopt a Resolution Declaring and Ordering the Disposition of Surplus Funds, a sample of which is provided herein for the LGVSD's reference.

### 1. SURPLUS FUNDS ANALYSIS

### 1.1. Los Ranchitos Zone Reserve Account (Account #73307)

Pursuant to Section 8885 of the California Streets and Highways Code, any excess in the Reserve Fund shall be apportioned to each parcel upon which the individual assessment remained unpaid at the time the balance in the Reserve Fund was sufficient to retire all outstanding Bonds. The payments shall be made in cash to the respective owners of the parcels except that, if the excess is not greater than \$1,000, the excess may be transferred to the general fund of the agency.

NBS recommends the surplus in the Los Ranchitos Zone Reserve Account be apportioned to owners of property within the District, as shown in Section 1.4 herein. No amount may be transferred to the LGVSD's general fund, since the surplus exceeds \$1,000.

### 1.2. Cash (Account #73304)

NBS recommends the cash account held by the LGVSD for the Reassessment District, which is not related to the Reserve Fund or Redemption Fund, be used to pay the administrative costs of preparing this report, and any remaining balance be transferred to the LGVSD's general fund, as outlined in Section 1.3 herein.
