WHEREAS, GCCI, Inc., of Santa Rosa, CA, executed a contract on February 21, 2015 in the amount of \$109,900 to complete Crew Lunch Room Modifications project, Job No. 12100-02, scope defined in Contract Documents and Specifications dated December 2014 prepared by District staff, for District ownership and maintenance;

WHEREAS, the District has authorized change orders in the total amount of \$2,312, for a total final project cost of \$112,212; and

WHEREAS, Michael P. Cortez, District Engineer for the Las Gallinas Valley Sanitary District by a Notice of Completion dated July 23, 2015, a copy of which is attached hereto as Exhibit A, has acknowledged that the aforementioned improvements have been installed, tested by the District, and found to be acceptable to the District, for District ownership and maintenance.

NOW, THEREFORE, the Board of Directors of the Las Gallinas Valley Sanitary District herein approves the Notice of Acceptance of Completion for recordation with the Marin County Recorder.

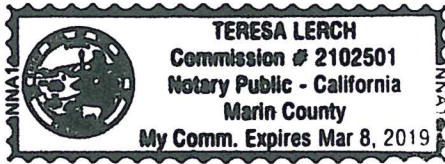
